### OTHER FEES/SERVICES:

- 1 An Intake/Orientation class is required for all adult parties, and anyone who will transport children to and/or from Hannah's House appointments. The cost is \$55 per legal party for visits; \$30 per legal party for exchanges; \$30 for transport person; \$75 for special schedule. Certificate given upon completion.
- 2 Court reports start at \$75 depending on the number of services covered by the report; 50% of the fee is paid by each party. One party may choose to pay all fees. Case account balances must be \$0. Rush fee required if less than 10 business days to produce report. Other options available.
- 3 Any memorandum requested by either party will be \$30. These memorandums take 5 business days.
- 4 Supervised Exchanges cost \$30 for a complete exchange: \$15 for each end of the exchange (transition from one parent to the other.) Discount for multiple exchanges in same week.
- 5 All children are required to attend a Turtle Tour Orientation of our facility on Tuesday evenings while parents are in orientation. The Turtle Tour is free, and is called "Turtles Travel Too." Completion certificates issued at time of orientation.
- 6 Administrative Fees are charged for early and late arrivals at the rate of \$1.00 per minute for all visitation and exchange appointments to strictly enforce arrival and departure procedures to prevent adult contact.
- 7 Breathalyzers are done by Court Order only and are \$25 each.
- 8 Clients that require excessive administrative time may be charged an additional \$25-\$50 per event.

### REQUIRED DOCUMENTATION: MUST BE PROVIDED PRIOR TO BEGINNING OF VISITATION SERVICES

- 1 Financially responsible party must bring one of the following for documentation: (a) copy of last three (3) pay stubs – must be detailed; (b) copy of subsistence check with supporting documentation – Unemployment or Disability; (c) copy of last three year's tax return; or (d) copy of last six (6) month's bank statements.
- 2 Copies of FCS reports - most recent/current and past.
- 3 Copies of Court-Orders: current only unless portions of previous orders are still in force; **MUST INCLUDE AMOUNT OF CHILD SUPPORT.**
- 4 Copies of ALL Temporary and Permanent Restraining Orders on all parties who may come on House property. Must include all DV Forms including Declaration in support of the TRO.
- 5 Copies of Current vehicle registration, driver's license and proof of insurance for all individuals driving to and/or from Hannah's House.
- 6 DV Forms/Filings only on Supervised Exchanges if both parties agree on the court order and schedule.
